For over 160 years, Sydney University Football Club (SUFC) has been a cornerstone of Australian rugby, nurturing talent and fostering excellence. However, the rising cost of living in Sydney poses significant challenges for young athletes from regional or disadvantaged backgrounds. Many promising players are forced to choose between pursuing their rugby dreams and affording accommodation in the city.

Trilogy Funds is proud to support SUFC's new Housing Fund - an initiative designed to ensure that talented players aren't hindered by financial constraints.

Through this initiative, Trilogy Funds will donate an amount equivalent to 1% of every SUFC member's or eligible family members' investment in the Trilogy Monthly Income Trust (Trust) to SUFC. A shining example is David Lyons, a former Wallabies captain and SUFC alumnus who hails from regional New South Wales. ## David Lyons - From country roots to international rugby

David Lyons' journey epitomises the potential that lies within regional Australia. Born in Orange, New South Wales, Lyons only began playing rugby at 16 while attending Hurlstone Agricultural High School. His natural talent quickly shone through, leading to selections for the NSW Country U16s and Australian Schoolboys teams. In 1999, he moved to Sydney to attend the University of Sydney and joined SUFC, where he further honed his skills.

Lyons made his Super Rugby debut for the Waratahs in 2000 and earned his first cap for the Wallabies the same year. Over his career, he amassed 44 Test caps, participated in two Rugby World Cups (2003 and 2007), and was awarded the John Eales Medal in 2004 as Australia's Player of the Year. His professional journey also included successful stints with the Scarlets in Wales and Stade Français in France.

Lyons' story underscores the importance of providing support and opportunities to young athletes from regional areas. The SUFC Housing Fund aims to pave the way for future players like David, ensuring that financial barriers do not impede their potential.
